The conditions mentioned in this document are to develop a Massive Open Online Course (MOOC) or mini (MOOC) for the early childhood development (ECD) material to raise general awareness and improve practices among pediatricians about comprehensive ECD.

#### **Background**

The Royal Health Awareness Society (RHAS) is working on upskilling healthcare providers in early childhood development(ECD) project with the support of Bernard van leer foundation to raise general awareness and improve practices among pediatricians about comprehensive ECD, in partnership with the American Academy of Pediatrics (AAP), Ministry of Health and national entities.

In order to achieve this goal, the project is based on a set of interventions, including upskilling of pediatricians in ECD, Development of a comprehensive ECD training package to conduct Training of Trainers (ToT) on ECD for 20 pediatricians, in order for them to be master trainers for additional 200 pediatrics.

- 3. Company Profile, including the reach of the platform
